# How Can We Help Your Family?

- Assist with developing parenting structure and routines.
- Link and assist families in navigating community resources.
- Mentor families in home management and organization.
- Aid in seeking out medical/dental services for the family.
- Promote family stability.
- Help address family needs to prevent future involvement with CPS.

# **What To Expect**

- Prevention services are voluntary, and the family must agree to participate with this service
- At least monthly face-to-face contact with the assigned Prevention worker (contact can be more frequent based on family's needs and requests)
- Prevention workers will collaborate at least monthly with other providers working with the family to coordinate and provide support for the family (appropriate releases of information are required)

### **Referral Process**

- The Prevention program is a completely voluntary program to support and build healthy families in the community. The family must be aware of the referral and agree to participate
- Feel free to reach out to your local Prevention Team and ask them to discuss services directly with a potential family prior to referral
- Referrals can be made by community partners and MDHHS staff by submitting a local office Prevention Referral Form to the local Prevention supervisor. If you need a referral form, please contact your local Prevention Team.
